1	You will be appointed as Office Assistant (Multipurpose) on probation in grade/ pay scale (Rs. 11765-655/3 - 13730 - 815/3 - 16175- 980/4 - 20095- 1145/7 - 28110- 2120/1 - 30230- 1310/1 -31540) w.e.f. date of joining at the Branch / Office wherever you have been posted.
2	You will draw a Basic Pay of Rs.11765- (Rs. Eleven Thousand Seven Hundred sixty five only) every month along with Dearness Allowance, House Rent Allowance and other admissible allowances as per Service Rules & Regulations framed by the Bank from time to time.
