The DSSSB vide its advertisement No. 01/2014 had advertised 12 vacancies (UR-08, OBC-01, SC-01 & ST-02) including PH-01 (OH-OL,BL) for the post of Pharmacist (Ayurveda) under post code 10/14, in DISMH with closing date 27.02.2014. One tier written examination was conducted on 27.08.2017 wherein 57 candidates appeared.
2. The marks obtained by 56 candidates who have appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssonline.nic.in.
3. OMR of candidate having roll number 16300183 was not evaluated as candidate has not correctly bubbled his/her roll number in the relevant space/column; accordingly his/her candidature is hereby cancelled.
4. Based on the performance in the examination, candidates, as detailed below, have been provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
