Whereas, in response to the above notification dated 04.01.2018, One Hundred Six (106) candidates (Out of 130) submitted their certificates/documents in the Directorate of School Education Kashmir, within the stipulated period and Twenty-four (24) candidates failed to do so:

Whereas, in pursuance to Administrative Department's communication No. Edu-I/77/2017 dated 08.01.2018, this office issued notification vide No. DSEK/Estt/III/B-Trs/PMP/017/726-28 dated 06.03.2018 in favour of **Sixteen (16)** candidates who make it to the selection zone after equal number of candidates failed to respond to the final notice;

Whereas, in response to the notification dated 06.03.2018, **Three (03)** candidates from waiting list in District Cadre Srinagar failed to submit their documents within the stipulated time period;
