It is hereby notified that on the basis of the results of the Written Test (Main) held on 17/08/2017 to 28/08/2017 and Oral Test (Interview) held from 12.03.2018 to 23.03.2018 & 11.04.2018 for recruitment to the posts falling under Group-I Services ( General), the candidates whose Register Numbers are given below have been provisionally selected for appointments to the posts mentioned below, notified vide Commission's Notification No. 36/2016, dated:30.12.2016 (G.R) subject to the following conditions.

- I. That success in the examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate having regard to his/her character and antecedents are suitable in all respects for appointment to the service,
- II. That the candidates are found physically fit for the post;
- III. That the candidates should produce such other original certificates as may be required in accordance with the Rules.

If it comes to the notice of the Commission later that any candidate furnished false information or the selection is not in order due to any act of omission or Commission of any candidate then his/her provisional selection is liable to be cancelled at any stage and he/she will forfeit all consequential benefits including that of selection, besides the Commission reserves the right to take any action as it deems fit in the circumstances of the case, in terms of the various enabling provisions as notified in Notification No. 36/2016, dated:30.12.2016 (G.R).

3. The selection of BC-E candidates is subject to the outcome of Civil Appeal No. (a) 2628-2637 of 2010 in SLP. NO. 7388-97 of 2010 dated 25/03/2010 and orders from the Government and other cases pending if any.

4. Selection and appointments made under this Notification is subject to final decision in O.A. No. 403 of 2018, O.A.No.533 of 2018 pending before Hon'ble APAT, and other cases pending if any.
