

**List of the Candidates Selected & Waitlisted for the post of Executive Engineer (Trans) published vide Advertisement No. 02/2017**

In pursuant to the Advertisement No. 02/2017 published on 18.10.2017, the On-line Test (examination) for the post of **Executive Engineer (Trans)** was conducted on 12.01.2018. Subsequently, Personal Interviews of eligible shortlisted candidates were held on 23.03.2018 & 24.03.2018.

2. Now, taking into consideration the performance reflected in the on-line Test (examination) & personal interview, number of post advertised and social reservation etc., the select and wait list of candidates for the post of **Executive Engineer (Trans)** is prepared. However, this selection is **subject to outcome of the Writ Petition No. 8927/2018 filed by Shri. Yogesh Meghraj Chavan and others v/s MSETCL in the High Court of Judicature at Bombay.**

3. While drawing select list, marks obtained in On-Line Test (out of 150) have been converted into 95 marks and marks obtained in Personal Interview (out of 50) have been converted into 05 marks. Thus merit list has been drawn out of 100 marks.

4. The name appearing in select / wait list does not confer any automatic right of possible employment with the Company.

5. The selection of the candidates is purely on provisional basis subject to outcome of the above referred writ petition and conforming with the pre-requisites and other conditions notified in the advertisement. If it is found that the candidate is not meeting the required pre-requisites or not fulfilling any of the conditions, or he has knowingly or willfully furnished incorrect or false particulars / fake certificates or suppressed material information, his selection is liable to be cancelled and if appointed, shall be liable for dismissal from the Company's service without any notice or assigning any reasons whatsoever.

6. Appointment order of the selected departmental candidates will be issued by the concern establishment section after verification of relevant documents of the candidates, disciplinary actions and vigilance enquiries in process / contemplated and other service records as mentioned in the General Condition No. 16 in the Advertisement and clause no. 5 of notification dated 01.03.2018 and clause no. 7 of notification dated 09.03.2018. The decision of the Company in this regard shall be final and no individual representation will be entertained.

8. The select / wait list will be valid for the period of 1 year from date of publishing.

9. Every care has been taken in preparing the result. However, the Company reserves the right to rectify any inadvertent error or typographical mistake, if any occurred.

10. The decision of the Company in all regards shall be final and no individual representation / correspondence will be entertained.
