You are requested to follow the instructions as mentioned below:

1. After undergoing the medical examination, medically-fit candidates will be sent to SCI- MTI (Maritime Training Institute), Powai, Mumbai for ashore training. Medical Examination charges @ Rs 1500/- will be borne by the candidates.
2. Candidates shall bring all original certificates as mentioned in the advertisement.
3. Candidates will have to make their own arrangement for lodging/ boarding/ transportation etc prior reporting to MTI.
4. Candidates shall arrange at least one white shirt, one black trouser, a pair of black shoes, a boiler suit, a pair of safety shoes and civil dresses necessary during shore training.
5. Candidates shall pay a Demand draft of Rs. 1,00,000/- (Rupees One Lakh Only) before going for medical examination at SCI Head office on 22.03.2018 . The candidates shall make the Demand Draft in favour of "THE SHIPPING CORPORATION OF INDIA LTD." payable at Mumbai. The balance training course fees of Rs 3,50,000/- shall be paid at MTI within two months. On found to be **medically unfit**, demand draft of Rs.1,00,000/- would be returned to the candidates.
6. Training course will be commenced from 01.04.2018.
