



1. This offer is subject to the condition that you are declared medically fit for Government service by the Chief Medical Officer. You should appear before the concerned C.M.O. of your district immediately and furnish the Medical Certificate of Fitness before the Committee constituted at Head Office, Sinchai Bhawan, Sector-5, Panchkula.
2. You will be on probation for a period of two years from the date of joining. The probation period can be extended for another one year. In case, your work and conduct are not found satisfactory during the probation period, your services will be liable to be terminated without giving any notice or pay in lieu thereof.
3. This appointment is purely provisional (temporary). This post is liable to be abolished at any time and carries, no promise of subsequent permanent employment.
