**I. Scheme:**

- (a) The test will be of two hours duration and the medium of the test will be both Hindi and English.
- (b) The test will be an objective type with multiple choices of answers and will carry a maximum of 100 marks.
- (c) There will be penalty for wrong answer. Every wrong answer will carry a deduction of one-third of the marks assigned to that question. If no answer is marked for a question, there will be no penalty for that question.

- (c) Population, Development and Globalization

- (f) Accounting and Auditing, Industrial Relations, Labour Laws, Insurance
- (g) Basic knowledge of Computer applications, General Science
- (h) Elementary Mathematics, Statistics and General Mental Ability
- (i) Social Security in India
