FIELD ASSITANT IN DEPARTMENT OF FOOD SAFETY UNDER POST CODE 201/2014

- 1. The DSSSB vide its advertisement No 02/2014 with closing date 25.01.2015 had advertised 07 vacancies (UR-04, OBC-02, SC-1) for the post of Field Assistant in Food Safety Department under Post code 201/2014 in the pay scale of Rs. 5200-20200/- having Grade Pay of 2000/- (Pre- revised). Board has conducted One Tier Examination (G) for recruitment to this post on 30.07.2017. Marks of the 477 candidates who appeared in the examination and whose OMR sheet have been evaluated have been uploaded on Board's website vide notice number 601 dated 07.02.2018.
- 2. Based on the performance in the examination, 21 candidates were provisionally allowed to upload e-dossiers in the ratio of 1:3 of the advertised vacancies subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The e-dossier was made active wef 20.02.2018 to 07.03.2018 vide notice number 604 dated 20.02.2018. Later the e-dossier uploading date was extended upto 14.03.2018 vide notice number 607 dated 07.03.2018.
- 3. On the basis of the merit list of One Tier Examination and after preliminary scrutiny of eligibility for the post as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidate is provisionally selected for the post of Field Assistant in Department of Food Safety under Post code 201/2014.

- 8. The candidature of candidate having roll number 15002228 has been cancelled as the candidate failed to upload the requisite documents in the edossier inspite of extending the e-dossier link upto 14.03.2018 and sending the SMS at his registered mobile number in the OARS.
- 9. The selection of the above 07 candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason(s). The decision of the User Department regarding the 20 eligibility of the candidate shall be final and binding on the candidate.
- 10. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 11. The User department shall also check the eligibility of the reservation benefit in respect of the candidates who are selected in reserved categories. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- 12. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department

is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
