**RESULT NOTICE NO- 580**

**TGT (ENGLISH) (FEMALE) IN DIRECTORATE OF EDUCATION  
UNDER POST CODE 02/2010**

The DSSSB vide its result notices No 138 dated 11.03.2011, No 145 dated 28.06.2011, No 147 dated 01.07.2011, No 152 dated 27.09.2011, No 161 dated 03.02.2012, No 163 dated 17.02.2012, No 177 dated 04.05.2012, No 189 dated 20.07.2012, No 197 dated 28.08.2012, No 239 dated 18.2.14 and No 387 dated 10.05.2016 has declared result of 311 candidates including 246 candidates in UR category for the post of TGT (English) (Female) in Directorate of Education under Post code 02/2010 in the pay scale of Rs. 5500-9000 (pre-revised).

At the time of declaration of result of the candidature of Archana Aggrawal having roll number 216857, who has scored 126 marks, was rejected on the ground that she had not studied English Paper on all three years of Graduation. Hon'ble High Court of Delhi vide its judgment dated 11.05.2016 in the WP (C) 10300/2015 in the matter of Archana Agarwal vs GNCTD & Ors. in the light of their earlier judgment dated 07.08.2013 in the matter of Sachin Gupta has found the applicant eligible for the post.

In view of Hon'ble High Court vide its order dated 11.05.2016 in WP(C) 10300/2015 in the matter of Archana Agarwal Vs GNCT of Delhi & Ors whereby it has been directed to consider the candidature of Archana Agarwal (216857) for the post and the fact that all the UR vacancies for the post have already been filled and also the fact that Archana Agarwal has more marks as compared to last selected candidate in UR category in postcode 02/2010, accordingly nomination of Ms Rajni Lamba having roll number 214820, who was the last candidate having 93 marks and were selected vide result notice No 163 dated 17.02.2012 in compliance of Ld CAT order order dated 13.01.2012 in OA No 3723/2011 in the matter of Rajni Lamba vs DSSSB & Ors against the vacant posts of TGT (English) in general category is hereby rescinded.

In compliance of High Court judgement dated 11.05.2016 and on the basis of the merit list of Part-II examination of the post held on 06.06.2010 and after preliminary scrutinizing eligibility for the post as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidate is provisionally


The selection of the above Candidate shall be further subject to the through verification of the candidature of the candidate by the User Department including the identity of the candidate with reference to his photograph, signature, handwriting and thumb impression etc on the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.

The Competent Authority of the User Department shall arrange to verify the correctness of the information/ document as furnished in the application form vis-à-vis from the original documents as well as authenticity of document/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
