"In the meanwhile, respondent No.1 is directed to entertain the application form of the petitioner and allow him to compete in the process of selection for the post of Lecturer in the discipline of Conservative Operative Dentistry at his own risk and responsibility. Mere participation of petitioner in the process of selection would not entitle him to be eligible for the post in question, which issue shall be determined after objections are filed."

Whereas, the interview of the candidates was conducted on 28.05.2018 with the assistance of experts; and

Whereas, the result of petitioner in SWP No.1547/2017 has been withheld pending orders from Hon'ble High Court even as no specific orders of Hon'ble High Court restrains PSC from declaring his result.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business &

Procedure) Rules, 1980 as amended from time to time and other related parameters, the list of the candidates who have appeared in the interview is enclosed as Annexure-"A" to this Notification.
