Whereas, the Commission notified this post vide Notification No. 03-PSC(DR-P) of 2016 dated:19.02.2016; and

Whereas, in response to the above notification, **08** applications were received. Out of these, 05 applicants were found eligible and called for interview in which only two candidates appeared; and

Whereas, the interviews of the candidates were conducted on 23.01.2018 with the assistance of experts from outside the State.
