### **FINAL SELECT LIST**


In pursuance to the Notification dated: 09.11.2016 cited at (Ref-1) recruitment process to fill up 07 vacancies of Armed Reserve Sub-Inspector (CAR/DAR) (Men) in HK region posts was initiated and after the recruitment process this Office published First Provisional Select List for the above posts on 27.05.2017. After publishing the First Provisional Select List, candidates selected were subjected for Medical Examination as prescribed in the Cadre and Recruitment Rules called the Karnataka State Police including Ministerial Services (Recruitment) (Amendment) Rules, 2009. After conducting the medical examination, based on the report of the Medical Board Second Provisional Select List was published on 25.11.2017 (Ref-2). After publishing the Provisional Select List the concerned IGP / Commissioner who is the Appointing Authority was requested to verify the character and antecedents and also the other reservations claimed by the candidates selected in the Provisional Select List. After verification the report has been sent to this Office by the Office of concerned IGP / Commissioner vide letters cited at (Ref-3). Thus as per C&R Rules, the Final
