NOTE II: A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of approval of this ranked list. The candidates can avail only one chance after the approval of the ranked list Candidates desiring to get their answer script rechecked may apply for rechecking within 45 days from the date of approval of this ranked list.

"Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered."
