**INSTRUCTIONS ON SUB-ENGINEER (ELECTRICAL)**  
**RECRUITMENT AGAINST NOTIFICATION NO.01/2016, DT: 03-01-2016**

1. It is to inform that, as per the Notification No. 01/2016 Dated 03.01.2016, Written Examination held on 06/11/2016 to the posts of Sub-Engineer (Electrical) in TSSPDCL and in pursuant to the common Judgement dated 07.03.2018 in WA.No.511 of 2016 and batch of the Hon'ble High Court, the candidates bearing the Hall Ticket Numbers mentioned below are called for verification of Original Certificates.
2. The candidates are required to produce the Original Certificates along with two sets of Photostat copies duly attested by Gazetted Officer, relating to Age, Qualifications, Latest Community Certificate, Latest Creamy Layer exemption certificate in case of B.Cs, Study Certificates (from 4<sup>th</sup> class to 10<sup>th</sup> class), Bonafide Certificates, Handicapped Certificate in respect of Physically challenged candidates, Original Hall Ticket and if any other certificates as specified in the Notification, at the time of verification of documents. No request will be entertained for subsequent submission of any of the above certificates. The Original Certificates will be retained with TSSPDCL on the day of attending for verification process.
3. The verification of the certificates will be held in O/o. the Chief General Manager (HRD), 2<sup>nd</sup> Floor, A Block TSSPDCL, Corporate Office, 6-1-50, Mint Compound, Hyderabad from **07.05.2018 to 09.05.2018 from 10:30 AM to 05:00 PM.**
4. If, on further Verification it is found that any candidate is not eligible with reference to the particulars furnished by him/her in the online Application Form /Check List / Certificates, the results of such candidate / candidates shall be cancelled at any stage of selection process.
5. The candidate is required to attend on his own costs and not entitled for any reimbursement of Traveling/Dearness charges. Request for change of scheduled dates will not be entertained and if not attended on the above said dates, the candidature will be disqualified and he will not have any right to claim for appointment for the post of Sub-Engineer/Elect against the said notification.

6. Mere verification of the original certificates doesn't confer any right for selection / appointment.
