At the time of reporting, the candidates must ensure that they fulfill the eligibility criteria in respect of age, category (SC/ST/OBC/PWD), and educational qualification etc. as stipulated in the advertisement/notification for CRP SO-VI by IBPS and produce original testimonials / documents for verification. Reserved category candidates are required to submit the Caste/PWD certificate as per Govt. of India guidelines (Specimen also available on Bank's Website in the Recruitment section).

At the time of reporting for document verification at respective institutes on 28.05.2018, the candidates will have to produce the following documents in original for verification along with a set of self attested photocopies:-

- a. Educational certificates / testimonials (mark sheets/ pass certificates/ degree certificate, PAN Card, Aadhar Card etc.)
- b. Appointment Form, Secrecy & Fidelity Bond and Attestation Form duly filled in their own handwriting along with self attested photograph affixed at the appropriate place (copies of these forms are being sent separately along with soft copy of Appointment Letter).
- c. The enclosed Permanent Retirement Account Number (PRAN) duly filled form with all details therein.
- d. Original Scheduled Caste/Scheduled Tribe/Other Backward Class/Disability Certificate along with attested photocopy thereof, for verification, if applicable. For candidates belonging to OBC category, OBC caste certificate containing the Noncreamy layer clause should be valid as per Government Guidelines. Caste Name mentioned in certificate should tally letter by letter with Central Government list / notification and must specify that the candidate does not belong to Creamy layer section excluded from the benefits of reservation for OBCs. Please note that respective caste certificate is as per the performa prescribed by the Government of India and should have been issued by the competent authority.
- e. If employed, a clean relieving certificate from your present employer stating therein that there is nothing against you and that no dues are pending.
- f. Medical certificate of your fitness from a Registered Medical Practitioner not below the rank of M.B.B.S. (Format available on Bank's website)



g. Three additional passport size photographs of your frontal pose duly self attested at the back thereof.

The Caste/Tribe/Community certificate issued by the following authorities in the prescribed format for SCs/STs/OBCs will only be accepted as proof in support of a candidate's claim as belonging to the Scheduled Caste or Scheduled Tribe or Other Backward Class:

- District Magistrate/Additional District Magistrate/Collector /Deputy Commissioner/Additional Deputy Commissioner/ Deputy Collector/ 1st Class Stipendiary Magistrate/Sub Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
- ii. Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/Presidency Magistrate;
- iii. Revenue Officer not below the rank of Tehsildar; and
- Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

Those candidates who fail to produce required original documents will not be allowed to join the Bank.

The candidates are informed that in case it is detected at any stage, either at the time of verification of documents or even after appointment in the Bank, that any candidate does not fulfill the eligibility norms or do not satisfy the eligibility criteria stipulated in the IBPS notification and/or has furnished any incorrect/false information/certificates/documents or has suppressed any material fact(s), his/her candidature may be cancelled or his/her services are liable to be summarily terminated.
