SHORTLISTING OF CANDIDATES ON THE BASIS OF WRITTEN EXAMINATION CONDUCTED ON 30.08.2015 FOR APPEARING IN SKILL TEST (TYPING TEST) FOR THE POST OF CLERICAL ASSISTANT UNDER POST CODE 153/14 IN NDMC.

1. DSSSB conducted written examination on 30.08.2015 for recruiting to the post of Clerical Assistant under post code 153/14 in NDMC. Based on performance of the candidates in written examination, 362 (UR-171, OBC-100, SC-23, ST-60, PHOH-06 & PHVH-02) candidates have been shortlisted and eligible to appear for Skill Test subject to their fulfilling all conditions of eligibility and also correctness of the information furnished by the candidates in the OARS (Online Application Registration System).
2. Skill test was conducted by the Board and result was issued by DSSSB vide result Notice No. 577 dated 17.11.2017. However some vacancy in PH/OH category still remained unfilled. To fill the remaining unfilled 01 vacancy in PH category 06 additional PHOH candidates have been shortlisted to appear for Skill Test subject to their fulfilling all conditions of eligibility and also correctness of the information furnished by the candidates in the OARS (Online Application Registration System).

Further the candidates who have not qualified the skill test or are absent in the skill test are not being shortlisted further for the Post code 153/14 as shortlisting these candidates will not serve the aim of filling the unfilled vacancies as they have been disqualified/absent in the skill test already and hence there is no question of shortlisting them.
4. Mere inclusion of names in the list for shortlisting the candidates for appearing in Skill Test does not entitle the candidates any right over the post.
5. The shortlisting of candidates for appearing Skill Test is purely provisional subject to verification of credentials for determination of eligibility for the post to be carried out by the Board after completion of Skill Test. Shortlisted candidates whose Roll Numbers are indicated in this notice will be called for Skill Test separately by DSSSB.
