This offer is being made on the following terms and conditions:-

1. Engagement Terms:

- a. The appointment would be made purely on contractual basis for a period of one year from the date of joining or till the joining of regular candidate, whichever is earlier as per the provision of Haryana State Outsourcing Policy dated 06.04.2015. The services of the person so engaged shall hereafter cease on the expiry of the term without providing him/her any claim for the regularization of services or any other consequential benefit. The person so engaged shall not have any legal right claiming regularization of his/her services etc. in the Department where he/she has been engaged.
- b. His/her services can be terminated before the contract period without any prior notice, if any mis-conduct or poor performance on his/her part is observed/ reported.
- c. In case he/she has to leave his/her job before contract period he/she has to serve two months' prior notice or to deposit two months' emoluments in lieu of the notice period which remains short.
- d. The Candidates is required to enter into an agreement before joining as per the provisions of Out Sourcing Policy issued by the Govt.

- e. Any request for change of place of posting will not be entertained in any case.

2. Payment Terms:

The payment terms and other facilities will be as follows:

- a. The emoluments of the selected candidates will be paid 50% of the initial pay (Entry level pay in the first cell of respective level of pay matrix + D.A. as admissible from time to time) or fresh entered regular employee after 01.01.2016 subject to minimum of Rs. 9258/- per month or as fixed by the State Govt. (In General Administrative Department) from time to time.
- b. The Income Tax will be deducted at source as per the Rules of the Govt.
- c. He/she has to make his own stay arrangement and Department will not pay for it.

3. Nature of Duties

Nature of work: He/she is required to provide his/her services at departmental nursery. In addition to this the Controlling Officers may assign any work related to scheme which he/she will be bound to execute and implement as per the norms & guidelines. He/she will not leave the station/site without the permission of Controlling Officer and will report to the Controlling Officer or the officer nominated by Controlling Officer to report for the work assigned to him.

4. Area of Operation:

The area of operation shall be area defined by Controlling Officer within district and in no case shall extend to other district except in cases of training programmes and other district or state level functions organized or participated by the Department.
