- 3. The candidates are liable to be posted to work at High Court of Karnataka, Principal Bench at Bengaluru or any of the High Court Benches at Dharwad and Kalaburagi.
- 4. The inter-se seniority between the selected candidates will be in accordance with their ranking in the final selection List.
- 5. The candidates at the time of reporting to duty are required to execute a bond on Stamp paper (Non-Judicial) with an undertaking that they will serve in the office of the High Court for a minimum period of 5 years, failing which they will be liable to pay a sum of Rs.10,000/-(Rupees Ten Thousand Only) to this office.
- 6. The candidates have to report for duty within 15 days from the date of receipt of the order failing which their names shall be liable to be cancelled from the Final Selection List.
