- 1. Candidates are required to produce the following, at the time of reporting to the Bank:
 - a) Educational certificates in original along with attested copies (attested by any Gazetted Officer) thereof.
 - b) Attested copy of Matriculation certificate/Birth certificate issued by the Municipal Authority, as proof of age.
 - c) Certificate of Medical fitness from a Medical Officer not below the rank of District Medical Officer (Performa enclosed)/Civil Surgeon of district hospital.
 - d) Four passport size copies of your photograph.
 - e) Names and address of two references, not related to you but preferably known to the bank.
 - f) SC/ST/OBC Caste Certificate (wherever applicable) in the prescribed Performa.
 - g) Identity proof i.e. Aadhar, PAN etc.
 - h) Copy of IBPS application, Score Card CRP VI, Pre & Main examination and IBPS allotment letter.
- 2. Candidates are required to execute a bond of Rs 1,00,000/ with surety for serving the Bank for a minimum period of Three Years and in the event of resignation from the bank before the expiry of this period candidates must indemnify and pay to the Bank the said amount of the indemnity bond. The indemnity bond is to be executed before joining the Bank.
- 3. Candidates should produce a proper discharge certificate from your present employer (if any) at the time of joining the Bank at Head Office, Meerut on the stipulated date.
