1. With reference to the recruitment notification above for filling up 06 posts in Pay band -1 ₹ 5200-20200/-+ Grade Pay ₹ 1800/- (Pay Matrix Level 1; 7th, CPC) against Scouts & Guides Quota, written examination for all eligible applicants was conducted on 21/01/2018 and Scouting Skill Assessment Test for candidates qualified in the written examination was conducted on 24.03.2018.
2. Based on the marks obtained in the written examination, Scouts & Guides certificates and Scouting Skill Assessment Test, the following candidates have been provisionally empanelled against 06 notified vacancies in Grade Pay GP ₹ 1800/- post under Scouts & Guides Quota for 2017-18:

- 3 It may be noted that this empanelment is provisional and actual appointment/posting will be subject to the passing the prescribed Medical Examination, verification of antecedents and all certificate and testimonials including caste certificate.
- 4 The appointment of the above candidates on suitable posts in erstwhile pay Band-1 ₹ 5200-20200/- and Grade Pay ₹ 1800/- will be subject to requirement of administration and availability of vacancies. Two candidates each will be posted in BSP, R and NGP Division for which the candidates may submit their option for Divisions which will be considered on merit.
- 5 The candidates have to pass the mandatory training if any, attached to the post.
- 6 Individual offer of appointment will be sent separately to the selected candidates by Divns. against which the candidates are allotted.
- 7 The candidates if appointed will have to serve S.E.C.Railway a minimum period of 5 years from the date of posting/after training. Candidates will have to furnish individual "DECLARATION FOR APPOINTMENT" in the requisite proforma as per Annexure-III of Railway Board's letter E(NG)II/2015/RR-2/1 dated 21.09.2015 (RBE No. 110/2015 circulated under PCPO/SECR's Estt. Rule No. 162/2015). Any transfer application of the candidate/employee will not be entertained before completion of five (05) years.
