The result of the Roll No. 51000010, 51000432, 51000686, 51000718 and 51000983 has been kept in sealed cover in Compliance of direction of Hon'ble High Court in CWP No. 5272/2018 and the above result is subject to the final outcome of this writ petition and any other writ petitions pending in the Hon'ble Court.

The result of SBC/BC(C) category (11 Posts) has been withheld as per letter no. 42/187/2015-5GSI Dated:25.08.2016 issued by chief secretary, Government of Haryana in view of directions of the Hon'ble High Court that no appointments in service shall be made on the basis of the provision of the Haryana Backward Classes (Reservation in services and admissions in educational institutions) Act 2016 to the castes mentioned in schedule-III i.e. Backward Class Block 'C'. The SBC/BC(C) Category candidates,except those who have availed the benefit of age relaxation,have been considered against general vacancies.
3. The result of EBPG category (11 Posts) has been with held in view of the instruction no. 22/10/2013-IGSIII dated 21th Februrary, 2018 issued by the Chief secretary to Govt. of Haryana. The EBPG Category candidates, except those who have availed the benefit of age relaxation,have been considered against general vacancies.
4. As per Govt. Instruction no 22/15/1992-3GS III Dated: 07.10.2008, that if suitable candidates of Outstanding Sports Person are not available in a particular category, then the vacancy will be filled up from amongst the same category.
5. As per Govt. Instruction no 22/10/2010-1GS III Dated: 23.05.2014, that if suitable candidates of Ex-Servicemen are not available in a particular category, then the vacancy will be filled up from amongst the same category candidates.
