Objections received within aforesaid time and in aforesaid mode shall be taken into consideration. **However**, any objection/ clarification received without any authentic proof/source or any objection received after aforesaid stipulated period/time shall not be entertained/considered on any ground whatsoever, it may be and **shall stand rejected without assigning any reason**.

Objections/clarification received in aforesaid manner and mode and within aforesaid time limit along with self attested copies of the source/proof document shall be considered and the model Answers shall be finalized. The Model Answer finalized by the committee, so constituted, after taking into consideration objection(s)/clarification(s), if any, received from any candidate(s), shall be used as Keys/model Answer for the generation of result/valuation of the exam's 1<sup>st</sup> Question Paper OMR Answer-Sheets of candidates.

After declaration of result, no representation regarding any objection/clarification of any Model Answer/Questions, shall be entertained on any ground, whatsoever it may be and such representations received, if any, after declaration of the result, shall stand rejected without assigning any reason."
