## Terms and Conditions of Appointments

- He/She shall have to produce the following documents at the time of his/her joining:-1:
  - i) Medical fitness certificate from the C.M.O. concerned.
  - ii) Attested copies of Education Qualification Certificates.
  - iii) Character Certificate from a Gazetted Officer.
  - iv) Bonafide Himachali Certificate.
  - v) Certificate to this effect that he belongs to SC/ST/OBC, category, if any.
  - vi) Minimum Education Qualification Certificate i.e. Plus Two Certificate.
- That He/She. Shall be paid contractual emoluments per month, as may be fixed by the 2. Government from time to time.
- The service of the contract appointee will be purely on temporarily basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found 3.
- Contract Appointee will be entitled for one day casual leave after putting one month service.
