The DSSSB vide its advertisement No. 01/2015 had advertised total 10 vacancies {UR-07, OBC-02 & SC-01 *Including 02 PH-OH & 01 PH-HH) for the post of Deputy Manager (Accounts) under post code 27/15, in DTC with closing date 26.11.2015. Tier-I written examination was conducted on 14.05.2017. Further, the result for Tier-I Exam was declared vide result Notice No.581 dated 28/09/2017. Total six (06) {UR-01, OBC-01 & SC-04} candidates were shortlisted for tier-II examination.
- 2. The tier-II written examination was conducted on 03.06.2018 wherein 06 candidates appeared in tier-II exam.
- 3. The marks obtained by 06 candidates who have appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 4. Based on the performance in the examination, candidates, as detailed below, have been provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
