The DSSSB vide its advertisement No. 01/2015 had advertised total **91 vacancies {UR-48, OBC-24, SC-13 & ST-06 *Including 02 PH-OH & 01 PH-HH}** for the post of Junior Engineer (E&M) under post code 30/15, in DJB with closing date 26.11.2015. Tier-I written examination was conducted on 24/09/2017. Further, the result for Tier-I Exam was declared vide result Notice No. 426 dated 04/05/2018. Total 515 (UR-317, OBC-83, SC-130 & ST-28 including 02 PH) candidates were shortlisted for tier-II examination.
2. The tier-II written examination was conducted on 03.06.2018 wherein 468 candidates appeared in tier-II exam.
3. The marks obtained by 467 candidates who have appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssonline.nic.in**.
4. Based on the performance in the examination, candidates, as detailed below, have been provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
