Subject:- Declaration of Marks of Tier-II examination held on 03/06/2018 for the posts/post codes of Manager (Traffic) in DTC, Post Code-25/15, Dy. Manager (Traffic) in DTC Post Code-214/14, Dy. Manager (Personnel) in DTC Post Code-26/15 & Admin. Officer/Zonal Revenue Officer in Delhi Jal Board Post Code-67/12 and uploading e-dossier – regarding.

The DSSSB conducted two Tier common examination on 03.06.2018 for the post of Manager (Traffic) in DTC, Post Code-25/15, Dy. Manager (Traffic) in DTC Post Code-214/14, Dy. Manager (Personnel) in DTC Post Code-26/15 & Admin. Officer/Zonal Revenue Officer in Delhi Jal Board Post Code-67/12. The marks statement of the above Posts/Post Codes has been uploaded on the Board's website for information of the candidates.

Further, as per new examination scheme, the merit of the candidates has been prepared by giving 80% weightage of the marks scored in Part-I (Objective) paper out of 198 marks & 20% weightage of the marks scored in Part-II (Descriptive) paper out of 50 marks. All the qualified candidates based on the total weightage in both descriptive and objective papers have been shortlisted for uploading e-dossier.

The shortlisted candidates for the above mentioned posts/post codes are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link.

The link for uploading e-dossier shall be kept open for a period of 15 days w.e.f. **30/07/2018 to 13/08/2018**. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e., **26.11.2015 for Post Code-25/15 & Post Code-26/15, 25.01.2015 for Post Code-214/14 and 15.06.2012 for post code-67/12**. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. **The candidature of the candidates who fail to upload the e-dossier during the above said period will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.**

Further, each candidate is required to fill up e-dossier separately for different post codes. Common candidates, however, must give their order of preference of post codes in the prescribed format in annexure 'A' and upload the same in the e-dossier. Candidates must ensure that order of preference given in the e-dossier for different post codes is the same and not different. In case, different order of preference is given with e-dossiers for different post codes then the DSSSB shall have the right to take into consideration any one of them for selection of the candidate and the candidate shall lose the right of preferences given in other e-dossiers. The preference once exercised cannot be subsequently changed on whatsoever ground.

Mere asking the candidates for uploading documents in the e-dossier module does not confer them any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that the candidates who fail to upload their documents on or before the date as mentioned above will not be given any further opportunity and their candidature will be treated as cancelled.

Note: OBC (outsider) candidates have been treated as UR candidates.
