The DSSSB vide its result notice number 663 dated 01.06.2018 has provisionally selected 10 candidates for the post of Motor Vehicle Inspector (Male) in Transport Department under Post Code 64/2015. In the said result notice candidature of candidate having roll number 12300283 was kept pending in UR/OBC category for seeking the additional document from the candidate about his Ex-Servicemen Details.
- The candidate has now furnished the requisite documents, accordingly 2. after preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of Motor Vehicle Inspector (Male) in Transport Department under Post Code 64/2015 for consideration of the remarks mentioned against his name by the user department. DSSSB has however not undertaken veracity/scrutiny of experience certificate being technical in nature, therefore User Department must ensure the eligibility of the candidate in terms of the five years in a reputed automobile workshop which undertakes repairs of both light motor vehicles, heavy motor vehicles, heavy goods and passenger vehicles fitted with petrol and diesel engine as per the RRs and the correctness of the experience certificates furnished by the candidate at their own level.

All these selection is purely provisional subject to admissibility of the experience details furnished by the candidate in reference to the provisions as prescribed in the RRs for the post by the User Department. DSSSB has not undertaken veracity/scrutiny of experience certificate being technical in nature. Transport Department may ensure their correctness at its own level.
- 5. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 6. The User department shall check the eligibility of the reservation benefit/age relaxation, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- 7. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the Diploma, Driving License and Experience Certification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 8. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
