## POST GRADUATE TEACHER (HISTORY) (MALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 138/2012

The DSSSB vide Result Notice No 483 dated 15.03.2017 and Result Notice No 517 dated 12.06.2017 had declared the result of 58 candidates for the post of *Post Graduate Teacher (History) (Male)* in Directorate of Education under **Post code 138/2012**.

The representation dated 28.3.2017 filed by a candidate namely Sh Hemant Kumar having Roll number 26003658, who had scored 149 marks in Tier-II examination, was examined by the Board and in view of the fact that the candidate has acquired his MA qualification after the cutoff date, it has been decided that his candidature shall remain as rejected in postcode 138/12. Accordingly, the candidature of last selected candidate in SC Category namely Sh Rajesh Gautam having Roll number 26000519 which was withheld earlier vide result notice dated 12.6.2017 is hereby released.

Ld CAT vide its order dated 31.05.2017 has dismissed the OA 2234/2015 in the matter of Anurag Shrivastava vs GNCTD & Ans, an UR vacancy which was kept withheld on account of said court case is hereby released.

In view of above and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of PGT (*History*) Male under **Post code 138/2012:**

The candidature of candidates having Roll number 26000823, 26000143 and 26004177 are still kept pending for submission of requisite documents from candidates in UR Category.

The selection of the above 01 candidate shall be further subject to thorough verification of the candidature of the candidate by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the post or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

The User department shall also check the eligibility of the reservation benefit. Further User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
