Subject:- Declaration of Marks of Tier-II examination held on 03/06/2018 for the posts/post code of Publicity Officer in Labour Department Post Code-103/12 and uploading e-dossier – regarding.

The DSSSB conducted two Tier common examination on 03.06.2018 for the post of **Publicity Officer in Labour Department Post Code-103/12**. The marks statement of the above Post/Post Code has been uploaded on the Board's website for information of the candidate.

Further, as per new examination scheme, the merit of the candidate has been prepared by giving 80% weightage of the marks scored in Part-I (Objective) paper out of 198 marks & 20% weightage of the marks scored in Part-II (Descriptive) paper out of 50 marks. The qualified candidate based on the total weightage in both descriptive and objective papers has been shortlisted for uploading e-dossier.

The shortlisted candidate for the above mentioned posts/post code is hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link.

The link for uploading e-dossier shall be kept open for a period of 15 days w.e.f. **30/07/2018 to 13/08/2018**. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **15.06.2012 for post code-103/12**. The shortlisted candidate is also being separately informed through SMS & E-Mail on his/her registered mobile number & e-mail id. **If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.**

Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above will not be given any further opportunity and his/her candidature will be treated as cancelled.
