

Subject: - Select list of the candidate for the post of "Teacher.",(Education Department) in pursuance to Advertisement Notification No. 07 of 2010, under Item No. 696, (District Cadre) Jammu.

Order No:-742-SSB of 2017 Dated :- 6 -12-2017

1) Whereas, the Services Selection Board forwarded a select list of candidates for the post of Teacher (Education Department) in pursuance to Advertisement Notification No. 07 of 2010, under Item No. 696, (District Cadre Jammu) to Education Department vide No.SSB/Secy/Sel/012/2294-97 Dated:-03-09-2012 for further course of action and ;

- 2) Whereas, the petitioners namely Manmeet Kour D/o Gurdev Singh and Gurpreet Kour D/o Manmeet Singh among others, the petitioner have also applied for the above said post under OM category District Cadre Jammu in response to Notice/Notification No.07 of 2010 dated 12.11.2010 under item No.696;
- 3) Whereas, subsequently petitioners were shortlisted and called for interview at S.No.598 and 354 under OM category respectively and;
- 4) Whereas, their names were deleted in the final selection list issued by the Board after deleting the points accrued by virtue of PG degree as they have done the same through distance mode from Pondicherry University.
- 5) Whereas aggrieved by deletion of their names from final selection list the petitioners approached to the Hon'ble court by way of the instant writ petition bearing SWP No.2235/2012 with the prayer that the respondents, be commanded to issue appointment order in favour of the petitioners in terms of advertisement notification No.07 of 2010 dated 12.11.2010 as General line Teacher District Cadre Jammu. Further by considering the degree of MA(Sociology) obtained from Central University as valid degree for appointment for the post of teacher District Cadre Jammu.
- 6) Whereas, the Hon'ble High Court vide judgment dated 06.07.2017 has been pleased to dispose of writ petition No.2512/2012. The operative part of the judgment dated 06-07-2017 is reproduced as under:-

"In view of the aforesaid submission and in the fact of the case, this writ petition is disposed of with a direction to respondent to consider the claim of the petitioner strictly in terms of Government order NO.252-HE of 2012 and course under rule having regard to judgment/order dated 24.02.2016 passed in SWP No. 2512/2012 and order NO. 501-SB of 2016 dated 29.03.2016. Respondents shall pass appropriate consideration order within period of four weeks from the date a certified copy of this order along with complete set of writ petition and certified copy of order 24.02.2016".

It is further mentioned here that the Pondicherry University is a central University and as per Government Order No.252-HE of 2012, para a (II) the degree awarded through distance mode by the Central Universitites, established under the Act of parliament and having jurisdiction to extend their activitries in the etire country shall also be recognized.

Whereas, the last selected candidate in OM category was having total merit 57.643 however in terms of Govt. Order No. 252-HE of 2012, the PG degree of both petitioners are covered within the ambit of the Govt.Order.

Whereas, after considering their degree they shall enter into the selection list at

S.No.273/OM and 293/OM respectively.

Now, therefore, in compliance to the judgment of Hon,ble High Court dated.06-04-2017 passed on SWP No.2235/2012, MP NO.3414/2012 coupled with aforesaid facts the recommendation in favour of Manmeet Kour D/O S.Gurdev Singh figuring at S.NO.273/OM and Gurpreet Kour W/o S.Manmeet Singh 293/OM for the post of Teacher.",(Education Department) in pursuance to Advertisement Notification No. 07 of 2010, under Item No. 696, (District Cadre) Jammu are hereby released. The merit position/full particular of the petitioners is given at Annexure "A" to this order.

However, the other terms and conditions as conveyed in the main selection list shall remain the same.
